#### **DESCRIPTION**

DG10 is a disinfectant treatment (bactericidal and viricidal "encapsulated virus") cleaning surfaces and fabrics based on tensoactive products. Does not contain solvents, or NaOH (caustic soda). ### **HOW TO USE**

Before using the product, read the label carefully. It complies with the UNE-EN 13697 standard in dirty conditions. Chemical antiseptics and disinfectants. Quantitative non-porous surface test for the evaluation of the bactericidal and fungicidal activity of chemical disinfectants used in food products, in industry, at home and in the community. It complies with the UNE-EN 14476 Standard in dirty conditions, at a concentration of 80% with 5 minutes of contact and at a temperature of 20°C, for specific purposes with the test microorganisms Adenovirus type 5 and murine Norovirus. The application of the product in the food industry for use in contact disinfection: surfaces and equipment must be carried out in the absence of food. Instructions for use contact disinfection for use by professional personnel: surfaces and equipment, by spraying with trigger sprayers, cloth, immersion or recirculation with the pure product, respecting the contact times. Before applying the product, a thorough cleaning must be carried out. Avoid contact with treated or exposed surfaces. All necessary measures will be taken so that food, machinery or utensils that are handled on surfaces, premises or facilities previously treated or exposed to the aforementioned product do not contain residues of any of its components. To do this, the treated or exposed parts or surfaces that are going to be in contact with food must be properly rinsed with drinking water before use. Ventilate adequately after performing the disinfection treatment. Do not mix with other chemical products. Incompatible with organic matter, anionic detergents, ammonia derivatives and hypochlorites. A pretreatment test must be carried out to verify the compatibility of the product with the materials.

#### **APPLICATION**

Use in the food industry. Contact disinfection: application on surfaces and equipment by professional personnel.

DG10 is used for cleaning any type of surface that is not damaged by water such as (kitchens, tiles, upholstery, painted wood, panels, bathrooms, refrigerators, ovens, grills, extractor hoods, industrial floors, industrial machinery, cleaning of circuits, coolant deposits, among many others). The application is by spraying the product at a distance of about 25 cm.
